5)	Collect data to answer a scientific question or test a design solution	<ul> <li>Students collect/produce data</li> <li>a. to serve as the basis for evidence to answer a scientific question [science] or test design solutions [engineering] under a range of conditions</li> <li>b. about the performance of a proposed object, tool, process, or system under a range of conditions [engineering]</li> <li>c. that meet the <i>specific</i> goals of an investigation.</li> </ul>					
6)	Evaluate and/or revise an experimental design	<ul> <li>Students should:</li> <li>a. evaluate the accuracy of various methods for collecting data to determine the <u>most</u> appropriate.</li> <li>b. revise the experimental design, if needed, to collect/produce data that meets the specific goals of the investigation</li> </ul>					

\*This component is based on criteria required at the K-2 and 3-5 grade band. Making predictions/hypothesis may happen at the start of an experiment or towards the end depending on the level of experience students have with the content
